STEP 4 PROPOSAL/EVALUATION/SELECTION

SOSSEC, Inc:

- Notifies Project level performers from successful Plug-tests/Whitepapers
- Request Project Level Performer Proposals
- Assists and mentors NTDCs in effective preparation of Proposals
- Schedule group Webinar on Proposal preparation shortly after announcement. Responsiveness to requirements, use of Templates (per Recommended Processes and Practices for Open Technology and Agility for Innovation (OTAFI)", compliance with instructions, Milestone and pricing are topics that will be covered.
